THE OBJECTIVES OF HOLDING THIS EVENT ARE:

1.To setup an API User Group and Committee within the local region.

2.To provide a full-cycle of training in plant integrity management that covers Risk Based Inspection, Fitness for Service, Damage Mechanism and Pressure Relieving Systems.

3.TO BE ABLE TO KEEP THE USERS UPDATED ON THE CHANGES AND REVISION OF THE API TECHNOLOGIES AND STANDARDS.

4.To specifically introduce an RBI METHODOLOGY FOR PRESSURE RELIEF DEVICES, BASED ON THE LATEST RELEASE OF API 581.

FOR THE FIRST TIME, FRONTIUM IS PROUD TO ANNOUNCE OUR INITIATIVE TO SETUP AN API USER GROUP AND COMMITTEE IN THE LOCAL REGION. THE API GROUP IS A PLATFORM FOR THE USER TO NOT ONLY RECEIVE INFORMATION ABOUT THE ONGOING DEVELOPMENT OF THE TECHNOLOGY, BUT ALSO AN AVENUE TO SHARE EXPERIENCE AND PROVIDE FEEDBACK FOR THE ENHANCEMENT OF THE EXISTING API STANDARDS. THIS FORUM PROVIDES THE OPPORTUNITY FOR THE LOCAL INDUSTRY TO PARTICIPATE AND CONTRIBUTE TO THE ONGOING ENHANCEMENT OF THE STANDARDS.

TRADITIONALLY, COURSES LIKE RBI,FFS AND DM ARE OFFERED SEPARATELY, EACH BY DIFFERENT TRAINING PROVIDERS. USERS MIGHT NOT BE TAUGHT ABOUT THE CLOSE RELATIONSHIP BETWEEN ALL OF THEM IN ORDER TO SOLVE ANY SPECIFIC MECHANICAL INTEGRITY PROBLEM. API-U TRAINING PROGRAM NOT ONLY PROVIDES A FULL-CYCLE TRAINING THAT COVERS ALL OF THE MENTIONED SUBJECT, BUT WILL EVENTUALLY TEACH THE USERS HOW TO INTEGRATE THE APPLICATION OF THE DIFFERENT STANDARDS, SUCH AS INTEGRATING FFS AND RBI FOR A FULL LIFE CYCLE MANAGEMENT SYSTEM. THE SKILLS TO UTILIZE THE KNOWLEDGE FROM BOTH WILL BE INVALUABLE FOR THE USERS, PARTICULARLY IN SOLVING ANY LOCALIZED COMPLEX PROBLEM.

THE DYNAMIC NATURE OF API STANDARDS REQUIRES THE USER TO BE CONSTANTLY UPDATED ON THE LATEST DEVELOPMENT IN ORDER TO MAXIMIZE THE BENEFITS IN THE APPLICATION. HERE IN API-U, THE TRAINERS AND FACILITATORS WILL CONSIST OF THE KEY PERSONNEL WHO ARE INVOLVED IN THE DEVELOPMENT AND ENHANCEMENT OF THE TECHNOLOGY. AS THE EXPERTS OF THE SUBJECTS, THEY WILL BECOME THE KEY SPEAKERS WHO WILL CONTRIBUTE TO THE MOST VALUABLE EXPERIENCE FOR THE PARTICIPANTS. THIS PROGRAM IS ALSO AWARDED A CONTINUING PROFESSIONAL DEVELOPMENT (CPD) HOURS BY THE INSTITUTE OF ENGINEERS MALAYSIA. THE COMPLETE OFFICIAL API COURSES WILL FURTHER TAKE PLACE IN YEAR 2011 CONSIST OF MANY SUBJECTS INCLUDING BUT NOT LIMITED TO DAMAGE MECHANISMS AND PRESSURE RELIEVING SYSTEMS.

Notes on Fees:

•This fee structure holds the API regular (late) rates, but provides a larger discount for early registration (checking on this with API).

•All fees must maintain 20% discount for API Members (checking on possibility of a student fee that is lower than API Member fee).

•Group Registration Discount: For every five (5) registered in any session or course, a Company/Organization would get a free 6th registration in the same session or course.

•Late Registration can be lowered to less than 45 days before the course.

•The courses need a minimum of 20 participants each. We have no specific upper limit, but would probably say 40 to 50 students for a 3-Day course and 75 to 80 in the Tuesday short courses.

Refund Policy (agreed to with API on official courses):

•75% of the fee refunded if cancellation is received at least 14 days before the course •50% of the fee refunded if cancellation is received between 6 and 13 days before the course

•25% of the fee refunded if cancellation is received between 1 and 5 days before the course

•Substitutions for registrants unable to attend are acceptable.
